

Perth Racing Media Accreditation Application



PLEASE NOTE:

- Media Accreditation for Ascot and Belmont Park Racecourses, under the management of Perth Racing, is open to all practising bona fide media representatives.
- Seasonal media passes are issued annually from August 1 through to July 31, and will allow General Admission entry to all race meetings, including Carnival days.
- Passes are strictly non-transferable and are only for the use by the person to whom they are issued.
- The supply of seasonal media passes are issued on the proviso favourable or balanced reporting is provided to promote and support thoroughbred racing, equine management, wagering and venue and event management arranged by Perth Racing and its appointed contractors
- Please note that application does not guarantee approval.
- Accreditation is subject to Perth Racing's approval, which will be issued at the sole discretion of the organisation and a minimum of 14 days is required for processing of the application.
- Perth Racing has designated zones, which determine the different levels of Media Accreditation and site access as of 1 August 2017. Applicants will be advised of their accreditation status and access level.
 - Access Level 1 (Reporters and Journalists without a filming crew) – All public areas, Members Enclosure and Mounting Yard
 - Access Level 2 (Reporters and TV Hosts with a filming crew) – Selected areas only when accompanied by a Perth Racing representative
- Applicants will be advised of their accreditation status and access level.
- A completed Media Accreditation Rules and Regulations form and proof of current public liability insurance or an endorsement letter on company letter head must accompany every application.
- Incomplete applications will **NOT** be considered.
- If an event briefing is required for certain events, All accredited media will be asked to attend an event briefing and site tour.
- Accredited media will be supplied with a media access pass, a parking pass and an electronic media kit.
